ORDER

Our prices are fixed for the duration of an exhibition (2 to 15 days max.) And include delivery in France at official trade fairs or exhibitions (VAT not included).

To be registered, all orders must be made in writing using the Purchase Order form with the entire payment (by cheque or transfer), except contractual agreements with our sales department.

DELIVERY

The equipment will be available to the customer the day before the show opens. The responsibility of the tenant starts as soon as the equipment is delivered to the stand, even if the latter has not yet taken possession of his stand. No complaints will be accepted after 24 hours and after the equipment has been made available. ORSAEVENTS reserves the right to charge transport and labor for orders not accepted at delivery.

INSURANCE

« Risk and loss ». Insurance of the equipment is compulsory. The refusal to comply with insurance regulations automatically entails all responsibility to the customer for any loss or damage of the equipment. The guarantee of the flight is subject to the provision of a receipt for lodging a complaint with the competent authorities.

TENANT'S RESPONSABILITY

The customer is responsible for the leased equipment, from the delivery to the hand-over. The equipment delivered in good condition and must be used appropriately in its correct destination and without damage. The customer is responsible for any deterioration of the equipment. The rented furniture must be kept at our disposal empty of any content as soon as the exhibition closes, ORSAEVENTS can not be held responsible for the loss of objects,

goods or documents belonging to the customer which could have been left in the rented equipment. Keys should remain on furniture; In case of loss, they will be invoiced to the customer. In the event of force majeure, ORSAEVENTS reserves the right to supply, in replacement of the ordered furniture, equipment of the same value or of better quality. The rented equipment remains the property of ORSAEVENTS and can under no circumstances be moved or sold. Any dispute or litigation will be submitted to the Commercial Court of Montpellier which has exclusive competence.
